Developing a strong internal CEO succession bench is a responsibility for chairs and CEOs that will also form part of their legacy



Reflections from a recently appointed chair:

"I anticipated before taking my first Chair appointment that the role and responsibilities of Chair are utterly different from those of a CEO, especially with no direct control of resources to make things happen. The need to perfect a different leadership style, while in theory being obvious, is in practice more testing. So, mentoring support from seasoned Chairs was extremely helpful.

Whether as a first-time Chair taking on a settled 'steadystate' Board, or a team that has to be reshaped, one needs help to play oneself in.

Working with experienced Chair Mentors was invaluable in three key respects in being able to:

- pick their brains on the 'tools' of the job (for example, preparing for and running a good AGM)
- brainstorm the issues that needed to be addressed
- discuss freely anxieties and uncertainties, drawing upon the Mentors' experience of dealing with similar issues themselves, including the lessons they had learned from their own setbacks."




















Lord Charles Allen is one of the UK's most seasoned and versatile business leaders, with a career spanning media, infrastructure, consumer services, and financial services. He currently serves as Chair of Balfour Beatty plc (since 2021), one of Britain's leading infrastructure groups, and Chair of THG plc (since 2022), where he is supporting governance transformation and strategic renewal. He is Senior Independent Director at Global Media & Entertainment Ltd, the UK's largest commercial radio and digital audio business, a role he has held since 2007.

In parallel, Lord Allen serves as Chair of the Invictus Games Foundation and is an active member of the House of Lords.

His executive career included some of the UK's most prominent media leadership roles. As CEO of Granada Group and later Executive Chair of Granada Media, he played a pivotal role in the formation of ITV plc, where he served as CEO from 2003 to 2007. He subsequently led EMI Music as Executive Chair during a critical period of restructuring between 2008 and 2010.

His previous non-executive roles also include Tesco plc (1999-2010), Virgin Media, Endemol, and Chair of ISS A/S (2013-2021). He also served as an advisor to Goldman Sachs Private Equity and Chair of 2 Sisters Food Group, and Advisory Chair of Moelis & Company.

Beyond the boardroom, Lord Allen has played a central role in major national events and public service. He was Chair of the 2002 Manchester Commonwealth Games, Vice-Chair of the successful London 2012 Olympic Bid, and a member of its organising committee. He also acted as Chief Adviser to the Home Office (2007-2008), bringing private sector thinking to public policy.

Lord Allen was appointed CBE in 2003 and received a knighthood in 2012 for services to the creative and media industries. He became a life peer in 2013. With a career defined by pragmatism, clarity and institutional reform, he continues to support leaders navigating complexity, reputation and long-term transformation.

Thomas Thune Andersen is currently Chair of Lloyd's Register Group and Lloyd's Register Foundation (since 2012), where he leads one of the world's most respected maritime and safety institutions, with a focus on ocean sustainability, industrial integrity, and technological foresight. He is also Chair of VKR Holding A/S, a Board Member of BW Group and Cadeler, and Senior Independent Director at IMI plc—roles that reflect his broad oversight across infrastructure, engineering, and clean energy.

From 2016 to 2024, Thomas was Chair of Ørsted A/S, where he supervised the company's landmark transformation from a fossil-fuel-based utility into a global leader in renewable energy. His tenure is widely recognised for its strategic clarity, board discipline, and acceleration of offshore wind development on the international stage.

Earlier in his career, Thomas spent over three decades at the A.P. Moller—Maersk Group, where he held senior executive positions including President & CEO of Maersk Inc. and CEO of Maersk Oil. These roles gave him deep global operational leadership across shipping, logistics, and upstream energy.

Thomas is a member of the Danish Committee on Corporate Governance, a Commissioner at the Energy Transitions Commission, and a Freeman of the City of London. He is widely respected for his steady strategic judgement, institutional stewardship, and ability to lead through complexity—qualities in increasing demand across the evolving energy, maritime, and industrial sectors.

He served as Group CEO of Spirax-Sarco plc (2014–2024), a FTSE 100 leader in steam and thermal management, where he oversaw a decade of strong organic growth, international expansion and strategic acquisitions.

During his tenure, Mr Anderson positioned Spirax-Sarco as a purpose-led, high-performance business at the forefront of energy efficiency and industrial decarbonisation. He led the integration of companies such as Chromalox and Gestra, repositioning the group for the clean energy transition while maintaining an exceptional track record of creating shareholder value.

Before joining Spirax-Sarco, he held senior executive roles at Smiths Group, Alcoa, and Foseco Minsep, with leadership experience spanning Latin America, Asia, and Europe. He brings a global perspective to manufacturing, supply chain transformation and technical innovation, with particular expertise in highly engineered industrial components and systems.

Fluent in four languages and educated in engineering and business, Nick is recognised for his pragmatic leadership, systems thinking, and ability to guide companies through transformation with discipline and a long-term focus.

Douglas's journey at Ecolab began in 1989, when he joined from Procter & Gamble and quickly advanced through leadership roles in marketing and operations across North America and Europe. As President & COO (2002-2004), he built a foundation of discipline and strategic clarity before taking the helm as CEO. Under his leadership, Ecolab executed targeted, high-impact acquisitions, embedded digital and sustainability-led innovation, and earned accolades such as the 2018 Deming Cup for Operational Excellence.

Post-Ecolab, he founded E2SG Partners (2022), an investment firm focused on environmentally sustainable growth. His current board and trustee positions—at Target, Merck & Co., the Mayo Clinic, the College of the Holy Cross, and the National Restaurant Association Educational Foundation—reflect a continuing commitment to mission-oriented governance and institutional impact.

A graduate of the College of the Holy Cross and former P&G marketer, Douglas is respected for combining business discipline with environmental and social purpose. His career demonstrates how strategic leadership, institutional growth, and mission-driven governance can reshape a global enterprise with a positive impact.

He also holds several prominent non-executive directorships, including at The Economist Group, and has previously served as Senior Independent Director at GSK plc and Marks & Spencer plc, and Non-Executive Director at Thomson Reuters and Maruti Suzuki.

His leadership extends to Chair of Marie Curie, board roles in the International Chamber of Commerce UK, and Saïd Business School's Leadership Council.

Vindi holds degrees from IIT Delhi (B.Tech.) and IIM Ahmedabad (MBA) and is a Padma Bhushan honouree. He is known for his strategic clarity, inclusive leadership, and ability to balance commercial goals with societal impact—a trusted voice in both business and public institutions, navigating transformation and trust.

During his leadership, McKinsey deepened its capabilities in digital transformation, sustainability, and public sector advisory, while advancing diversity and inclusion across the partnership. He previously served as the firm's Asia Chair (2004-2009) and was based in Seoul, Shanghai and Toronto.

In 2019, he was appointed Canada's Ambassador to the People's Republic of China (2019-2021), where he played a critical role in navigating a period of heightened diplomatic tension, overseeing bilateral trade issues, and leading complex consular negotiations.

Beyond Rio Tinto and LeapFrog, Dominic has held several influential board and advisory roles. He was Chair of Teck Resources (2018-2019), a Non-Executive Director of Singtel, a Non-Executive Director of Investor AB, and an advisor to the Singapore Economic Development Board. He also chaired Canada's Advisory Council on Economic Growth, tasked with shaping national growth strategies and immigration reform. He was also Chancellor of the University of Waterloo (2018-2024), where he supported the institution's global engagement and innovation agenda.

Educated at the University of British Columbia and as a Rhodes Scholar at Oxford University, Dominic is highly sought after for his global perspective, pragmatic intellect and ability to guide institutions through periods of profound change. His leadership continues to shape the intersection of business, government and society on the global stage.
